JUDGMENT

The petitioner is the Kerala Head Load Workers Welfare Board. They approached respondents 1 and 2 by Ext.P11 and P11(A) under Section 10(46) of the Income Tax Act, 1961, seeking exemption. The petitioner seeks an early disposal of the same by the authorities.

2. Learned Standing Counsel for the Income Tax Department expressed doubt regarding maintainability of the above applications and also seeks further time to get instructions.

Considering the nature of the directions to be issued, I am of the view, the matter need not be adjourned further. Accordingly, following directions are issued, there shall be a direction to the second respondent to consider Exts.P11 and

P11(A) after issuing notice to the petitioner within a period of three months. The maintainability of the applications also shall be considered by the respondents while deciding the matter. Till a decision is taken in the matter by the second respondent, all coercive steps pursuant to Ext.P6 series shall be kept in abeyance.
